#### **Current Status on OSP Guidelines**

- 1. Existing OSP Guidelines are ambiguous and not inline with emerging technology trends.
- 2. TRAI had issued recommendations on the Guidelines on 21<sup>st</sup> October, 2019 following response to Consultation Paper and Open House Discussion (OHD) by industry stakeholders.
- 3. Recently, TRAI had also responded to DoT's refer back.
- 4. DOT has allowed some relaxations on Work From Home(WFH) in the OSP guidelines due to COVID-19.
- 5. We understand that DOT is in final stage to issue new OSP Guidelines.



#### **Key Recommendations by TRAI**

- 1. Captive OSPs to be kept out of purview of OSP Guidelines.
- 2. Prior intimation for Data/Internet based OSP.
- 3. Permit single registration to cover all locations of OSP company. Intimation to DOT for addition/ removal of any locations.
- 4. BG requirement for each location to be removed.
- 5. EPABX at foreign location in case of international OSP to be allowed.
- 6. No mandate for registration or additional license for CCSP/HCCSP.



# **Key Recommendations by TRAI....continue**

- 7. Allow Work from Home (WFH) on intimation basis.
- 8. No need to get Network diagram approved by TSPs.
- 9. Interconnection of hot sites between domestic and international OSPs to be allowed.
- 10. CUG facility to be continued.
- 11. Internet connection at centralized location allowed.
- 12. Permit PSTN connectivity to the International OSP at the Indian end.
