# Introduction

## Operation Related: Equipment Procurement From Trusted Sources

### Issue in brief:

- Regulatory uncertainty: No trusted products approved, although some vendors approved as trusted source.
- Customer Service Impact: Delay in network expansion and services to customers especially in pandemic situation.
- Expanded Scope: CPE's as well as LIM and Security equipment are also included. Some of these are already tested as per TEC specs.

### ACTO's Requests:

- Expedite approval process and make it time bound.
- Exempt CPE and the Security equipment from the purview of NSCS.
- Consider deemed approval approach for products already approved to avoid duplication.

## Operation Related: Remote Access(RA) Approval Process

### Issue in brief:

- Onerous RA approval process: Resulting in inordinate delays.
- Delayed Network Expansion: RA is critical for new nodes as well as O&M activity for existing nodes.

### ACTO's Requests:

- Simplify the current process of prior approval to intimation basis.
- No further inspection/approval in case new node/site is added to the approved RA system.
- Consider doing away with RA approval as part of ease of doing business measures.

## Operation Related: Centralized Inspection/Audit by LSAs

### Issue in brief:

- Duplication: Periodic inspections/audits conducted by various LSAs on the same TSP under the same License.
- Differing Interpretations: Adds to legal uncertainty and lack of predictability.

### ACTO's Requests:

- License inspection/Audit should be conducted at central level.
- The same report can be shared with other LSAs.

## License Reform Related: AGR/Multiple Levy of LF

### Issue in brief:

- Consistency in AGR Definition: Definition of AGR under various licenses needs to be uniform.
- Pass through charges under ILD/NLD, ISP & Access Service License: Non-uniformity in pass through charges across all licenses leading to ambiguity.

### ACTO's Requests:

- Need clear definition or demarcation of telecom/non telecom revenue.
- Consistency of pass through: To keep simple and uniform, instead of using the term pass through charges, it should use the same verbiage as given in UL- VNO license amendments.

## License Reform Related: Emerging Technologies/Services

### Issue in brief:

- Voice Centric License-Current licenses/policies are primarily written with focus on the consumer/retail voice segment.
- Consider specificity of enterprise customers- Require to address the need of enterprise segment and emerging services.

### ACTO's Requests:

- Remove restriction in interconnectivity between PSTN and leased line based CUG/ IPVPN network created in ILDO/NLDO license.
- Allow Internet licensees to create VPN/ any WAN technologies.
- Remove restriction in active infrastructure sharing Between ISPs and NLDO/ILDOs.



## License Reform Related: Co-Terminus License Condition

### Issue in brief:

- Subsequent authorizations taken under UL license at different times get expired with the end of first authorization even after paying full entry fees.

### ACTO's Requests:

- Allow a full period or charge to pro rata entry fees.

## License Reform Related: Multi-Parenting in UL VNO Access

### Issue in brief:

- Multi parenting is not allowed for wireless.
- For wireline, non-level playing field between UL- VNO access (Cat B) & UL-VNO Access as multi-parenting is allowed using same EPABX for Cat B but not for the latter.
- Restriction a key bottleneck for growth of UL-VNO.

### ACTO's Requests:

- Permit multi-parenting under UL-VNO Access Authorization for wireless.
- For wire line, allow multiple NSOs be connected on a particular EPABX with the same conditions of logical bifurcation for UL VNO Access Authorization, as in case of UL -VNO Access Category B.
